## **Annual Fall Conference**

## Workday

There have been some questions pertaining to our work day. As salaried employees, there is no defined workday. The district uses a payroll system that does not accurately outline our actual work day. The system indicates that we work 7.33 hours per day, but this is not accurate and is only relevant to payroll entry. We are able to work beyond a regular eight-hour work day as most members already do. The schedule should be equitable across schools and offices and may be approved by your supervisor where adjustments are necessary.

## **Items of Interest**

- We have extended our contract and hope to begin negotiating later this year. Until a new contract is negotiated and ratified there will be no COLA
- Open enrollment is upon us. Sick Bank enrollment is open as well.
- If you need member support while working with another member then please let me know. We cannot allow others to get involved in Union member matters because that is detrimental to our membership.

## House Bill 2: Income Tax – Subtraction modification

"Thanks to the labor movement's hard work, the MD State and DC AFL-CIO was able to get this important bill passed that will restore a right that our members used to enjoy." House Bill 2 allows all union members in the state of Maryland to take a subtraction modification when filing their state income taxes for their union dues. All PSASA members are once again eligible to claim our monthly investment fees for subtraction modifications starting for any tax year after December 2022.

This victory is a stark reminder of what labor can achieve when we work collectively toward a common goal. We will continue advocating for positive change in favor of all union members during the next legislative session.
